- What is eHealth?
  - ehealth is the practice of health care supported by electronic media, either and both hardware and software, in the context of the need for increased quality and efficiency
  - ehealth efforts are moving forward all over the Philippines, albeit in a vertical manner

- What is Telehealth?
  - It is health care over a distance, subset of eHealth
  - Health professional to health professional, health professional to patient
  - The archipelagic nature of the Philippines and its health care system has led to efforts in implementing Telehealth

- What is Telehealth?
  - National Telehealth Service Program (NTSP), a collaboration of NTHC and DOH; it connects physicians in the field with more central specialists
    - Doctors to the Barrios program
    - Regionalization of specialist pool
  - Medical Teleparasitology is a form of telehealth

- What is the Philippine Health Information Exchange (PHIE)?
  - It is an effort to unify and harmonize the different eHealth efforts in the Philippines
  - Local health systems connecting to the exchange to contribute to and benefit from the shared information
  - MTP has this potential

- What are the ethical considerations?
  - Shared health information is always vulnerable to breach in PRIVACY and CONFIDENTIALITY
    - Secure information media
    - De-identify patient (removing all identifiable traits)
    - Informed consent nature of procedure, pros and cons,
      risks, identification of people involved, patient's rights

#### Overview of MTP

- What is the MTP?
  - The MTP is the network of health care
     professionals in diagnostic parasitology sharing
     information remotely using an online cloud
     application
  - Rules and Ethics in shared health information apply to any and all activities of the MTP


#### Overview of MTP

- What is the MTP System?
  - The online application (dubbed MTP System v1.0)
    has the capability to facilitate the following:
    - Conversations between medical technologists and parasitologists (and sharing of information)
    - Image submissions to enhance information sharing
    - Monthly reporting of case aggregates
  - Can be defined as "cloud-based"

# Overview of MTP

- What do I need before I can use the MTP System?
  - Image capture device, media device capable of connecting to the internet, [connection between the two], internet browser
  - Capacity to use the system
  - An account registered in the system
  - Information for sharing (case/s, images, other info)




